CREDIT CONDITIONS

1. I/We warrant that the information given is true and correct.
2. I/We agree that products are sold ex-store and dispatched at my/our risk, even if sent railage/or cartage paid, and the creditors responsible ceases when the products are handed to me/us or to my/our representative or to the cartage contractors or the South African Railways or skippers as the case may be.
3. I/We agree that claims shall lapse and be unenforceable unless lodged in writing within 24 hours of arrival of the product;
4. I/We agree that the product delivered under a sale remains the property of the creditor as long as the purchase price has not been paid. I/We have the right to resell the products or to process them, in the normal way of a business transaction, but do not have the right to pledge them to third persons without written agreement of the creditor. In the case of pledge to third persons, I/we are held to inform the creditor without delay.
5. I/We acknowledge that until payment of overdue invoices, the creditor is not bound to effect further deliveries and has the right to ask for payment in advance for further deliveries.
6. I/We am/are aware of the fact that the terms of payment are strictly 7 days from Invoice and hereby agree to pay interest at Ordinary Bank Rate of any amount/s exceeding these terms and conditions.
7. I/We acknowledge that credit facilities may be withdrawn by the creditor at any time without prior notice.
8. I/We consent to the jurisdiction of the Magistrate's Court , in respect of all actions arising out of the supply of products and services, and which would otherwise be beyond the jurisdiction of the Magistrate's

Court, such consent being consent as envisaged by Section 45 of the Magistrate's Court Act, 1944 (as amended).

9. I/We agree that should it become necessary for the creditor to proceed with legal action, the whole amount outstanding on account will immediately become due and payable notwithstanding the fact that a portion of the amount would not be payable in accordance with the agreed terms of payment.
10. I/We agree that a certificate issued by a Director or authorized employee showing the amount due and owing to the creditor at any given time shall be prima face proof of the facts therein stated for the purpose or all legal proceedings against me/us for recovery of the said amount and as evidence of the prevailing rate of interest chargeable on overdue amounts.

I/We acknowledge that I/we shall be liable for all legal costs on the attorney and client scale, collection fees and tracing fees that may arise from legal action taken by the creditor due to failure to redeem indebtedness to the creditor. Liability in this connection shall be dependent on the clear understanding that the creditor has given due written notice of the intended proceedings and for purpose of such notice, the above registered address shall be regarded as domicilium citandi et executandi.
